TEAT DIP-HP10 is a buffered, controlled pH, hydrogen peroxide teat dip. TEAT DIP-HP10 contains a minimum of 1% hydrogen peroxide. TEAT DIP-HP10 is composed of 1% hydrogen peroxide, 2% lactic acid, 6% glycerine.

DIRECTIONS: Prior to milking, dip teats in undiluted TEAT DIP-HP10. Wipe off with a clean towel after 15 – 30 seconds. After milking, reapply TEAT DIP-HP10. Do not rinse or wash off. Allow teats to dry before letting cows outdoors in cold weather to guard against chapping.
