**Uses**

**Directions**

- **for itching of skin irritation, inflammation and rashes:**

- adults and children 2 years of age and older: apply to affected area not more than 3-4 times daily
- children under 2 years of age: ask a doctor
- **for external anal and genital itching adult:**
  - when practical clean the affected area with mild soap and water and rinse thoroughly
- gently dry by patting or blotting with toilet tissue or a soft cloth before applying

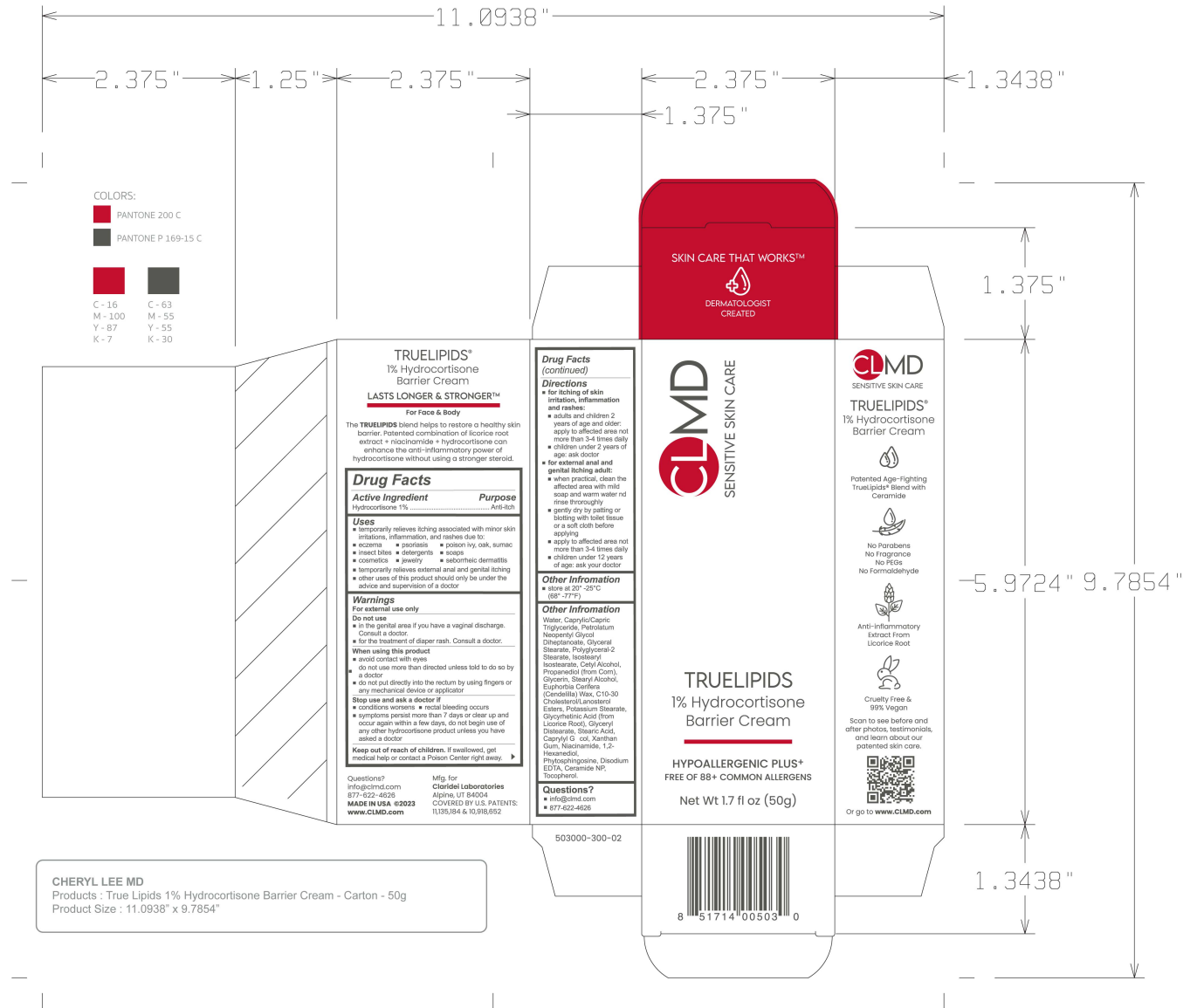
