**Warnings**

When using this product, if changes in behavior with nausea and vomiting occur, consult a doctor because these symptoms could be an early sign of Reye's syndrome, a rare but serious illness.

- allergic to salicylates (including aspirin) • taking other salicylate products

**Do not use if**

you have

- an ulcer
- a bleeding problem
- bloody or black stool

### **Ask a doctor before use if you have**

- fever
- mucus in the stool

### **Ask a doctor or pharmacist before use if you are**

taking any drug for

- anticoagulation (thinning the blood)
- diabetes
- gout
- arthritis

### **When using this product**

a temporary, but harmless, darkening of the stool and/or tongue may occur

### **Stop use and ask a doctor if**

- symptoms get worse or last more than 2 days
- ringing in the ears or loss of hearing occurs
- diarrhea lasts more than 2 days

**If pregnant or breast feeding,**ask a health professional before use.

### **Keep out of reach of children.**

In case of overdose, get medical help or contact a Poison Control Center right away.

### **Directions**

- chew or dissolve in mouth
- adults and children 12 years and over: 2 tablets (1 dose) every 1/2 hour or 4 tablets (2 doses) every hour as needed for diarrhea
- 2 tablets (1 dose) every ½ hour as needed for overindulgence (upset stomach, heartburn, indigestion, nausea)
- do not exceed 8 doses (16 tablets) in 24 hours
- use until diarrhea stops but not more than 2 days
- children under 12 years: ask a doctor
- drink plenty of clear fluids to help prevent dehydration caused by diarrhea

### **Other information**

- **each tablet contains:**calcium 140 mg, magnesium 9 mg
- salicylate 99 mg
- low sodium
- avoid excessive heat (over 104°F or 40°C)
