- do not take for symptoms that persist for more than 2 weeks unless advised by a doctor.

- **each tablet contains:**calcium 300 mg
- store at room temperature (20-25°C (68-75°F)). Keep the container tightly closed.
- do not use if printed seal under cap is torn or missing.
- Contains FD&C Yellow No. 5 (Tartrazine) as a color additive

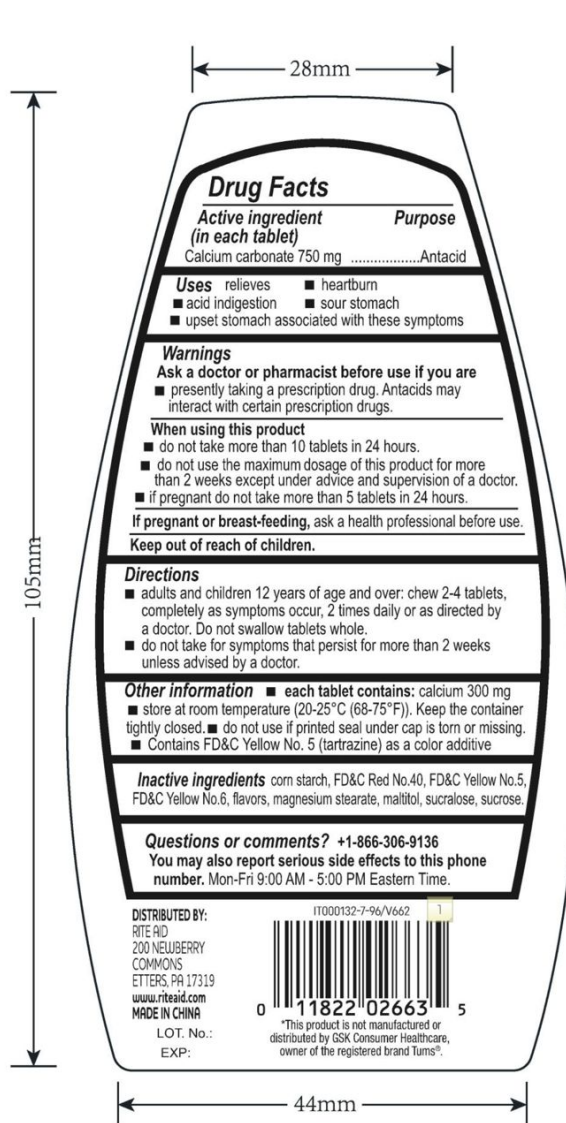
