- maximum use of 10 hours per day

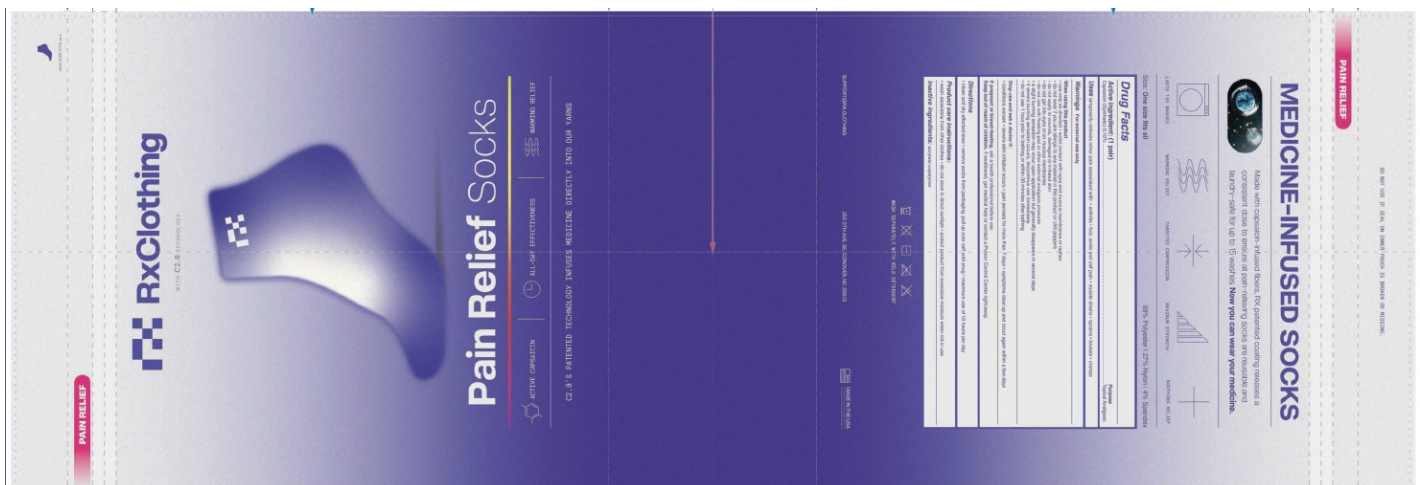
