 - wear long-sleeved shirts, pants, hats, and sunglasses

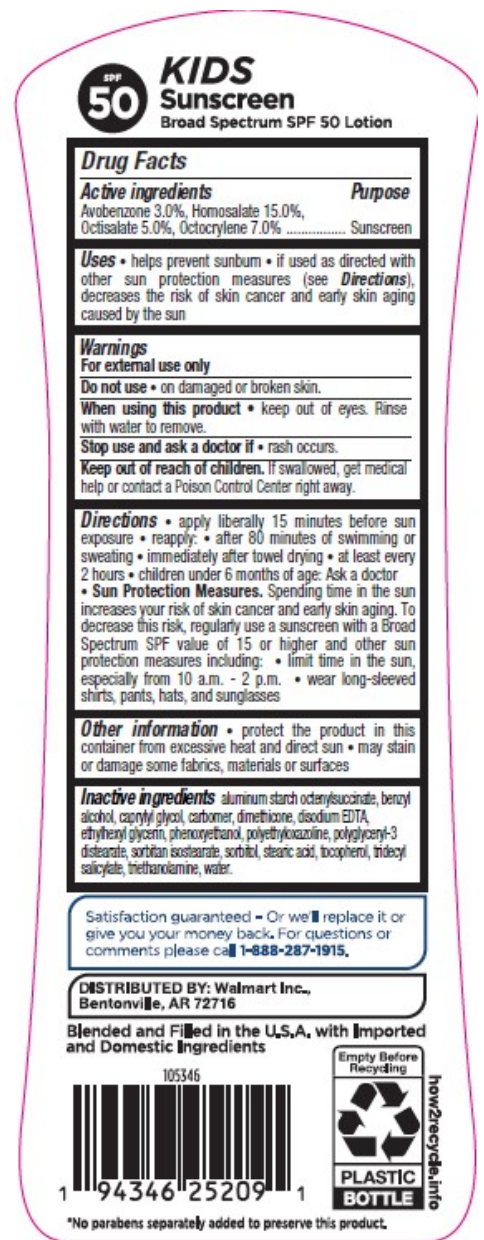
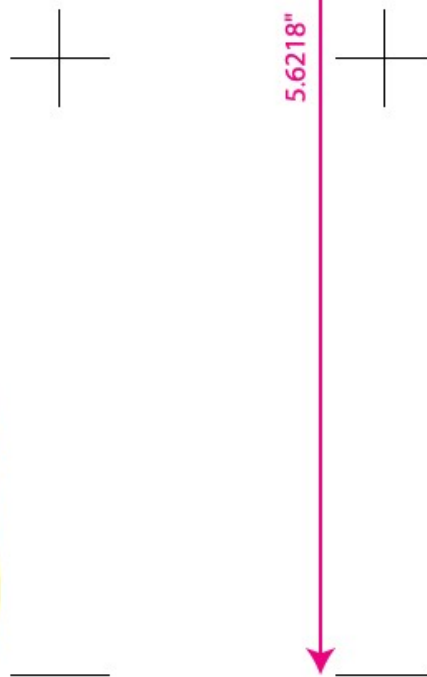
