# TDP-12x5

**TDP-12x5** is a concentrated, controlled pH, hydrogen peroxide based teat dip containing a minimum of 10,000 parts per million (ppm) of titratable hydrogen peroxide when diluted to use level. Mix 1 part **TDP-12x5** with 4 parts water to obtain proper usage level.

**DIRECTIONS:**

Prior to milking, dip or spray teats with diluted **TDP-12x5**. Wipe off with a clean towel after 15 – 30 seconds.

After milking, reapply diluted **TDP-12x5** by dipping or spraying. Do not rinse or wash off. Allow teats to dry before letting cows outdoors in cold weather to guard against chapping.
