Purpose

Topical anesthetic

Dosage and Administration

Directions Adults and children over 12 years:

- clean and dry affected area, free of lotions, ointments and creams.
- carefully remove backing from patch starting at corner
- apply sticky side of patch to affected area
- Do not use more than one patch in a 12 hour period. Repeat as necessary. Maximum 2 patches per day. Discard patch after single use. **Children under 12 years of age:** consult a physician.

For external use only.

Indications and Usage

Uses: Temporarily relieves minor pains.

When using this product

- use only as directed
- read and follow all directions and warnings on this carton
- do not allow contact with the eyes
- do not use at the same time as other topical analgesics
- do not bandage tightly or apply local heat (such as heating pads) to the area of use
- do not microwave
- dispose of used patch in manner that always keeps product away from children and pets. Used patches still contain the drug product that can produce serious adverse

effects if a child or pet chews or ingests this patch.

Stop use and consult a doctor

- condition worsens
- redness is present
- irritation develops
- symptoms persist for more than 7 days or clear up and occur again within a few days
- you experience signs of skin injury, such as pain, swelling or blistering where the product was applied.

If pregnant or breastfeeding, ask a health professional before use.

Do not Use

- more than one patch on your body at a time
- on cut, irritated or swollen skin
- on puncture wounds
- for more than one week without consulting a doctor
- if you are allergic to any active or inactive ingredients
- if pouch is damaged or opened.

Keep out of reach of children and pets.

If swallowed, get medical help or contact a Poison Control Center (1-800-222-1222) right away.

Other Safety Information

Store in a clean, dry place outside of direct sunlight. Protect from excessive moisture.
