### **Warnings**

#### **For external use only**

#### **Do not use**

- more than 1 patch at a time
- on wounds or damaged skin
- with a heating pad
- if you have ever had an allergic reaction to this product or any of its ingredients

#### **When using this product**

- use only as directed
- avoid contact with the eyes, mucous membranes or rashes
- do not bandage tightly

#### **Stop use and ask a doctor if**

- localized skin reactions occur, such as rash, itching, redness, irritation, pain, swelling and blistering
- conditions worsen
- symptoms persist for more than 7 days
- symptoms clear up and occur again within a few days

#### **If pregnant or breast-feeding,**

ask a health professional before use.

#### **Keep out of reach of children.**

**Directions****Adults and children 12 years of age and over:**

- clean and dry affected area
- remove film from patch and apply to the skin (see illustration)
- apply 1 patch at a time to affected area, not more than 3 to 4 times daily
- remove patch from the skin after at most 8 hours of application

**Children under 12 years of age:** consult a doctor

**Other information**

- avoid storing product in direct sunlight
- protect product from excessive moisture
- store at 20-25°C (68-77°F)

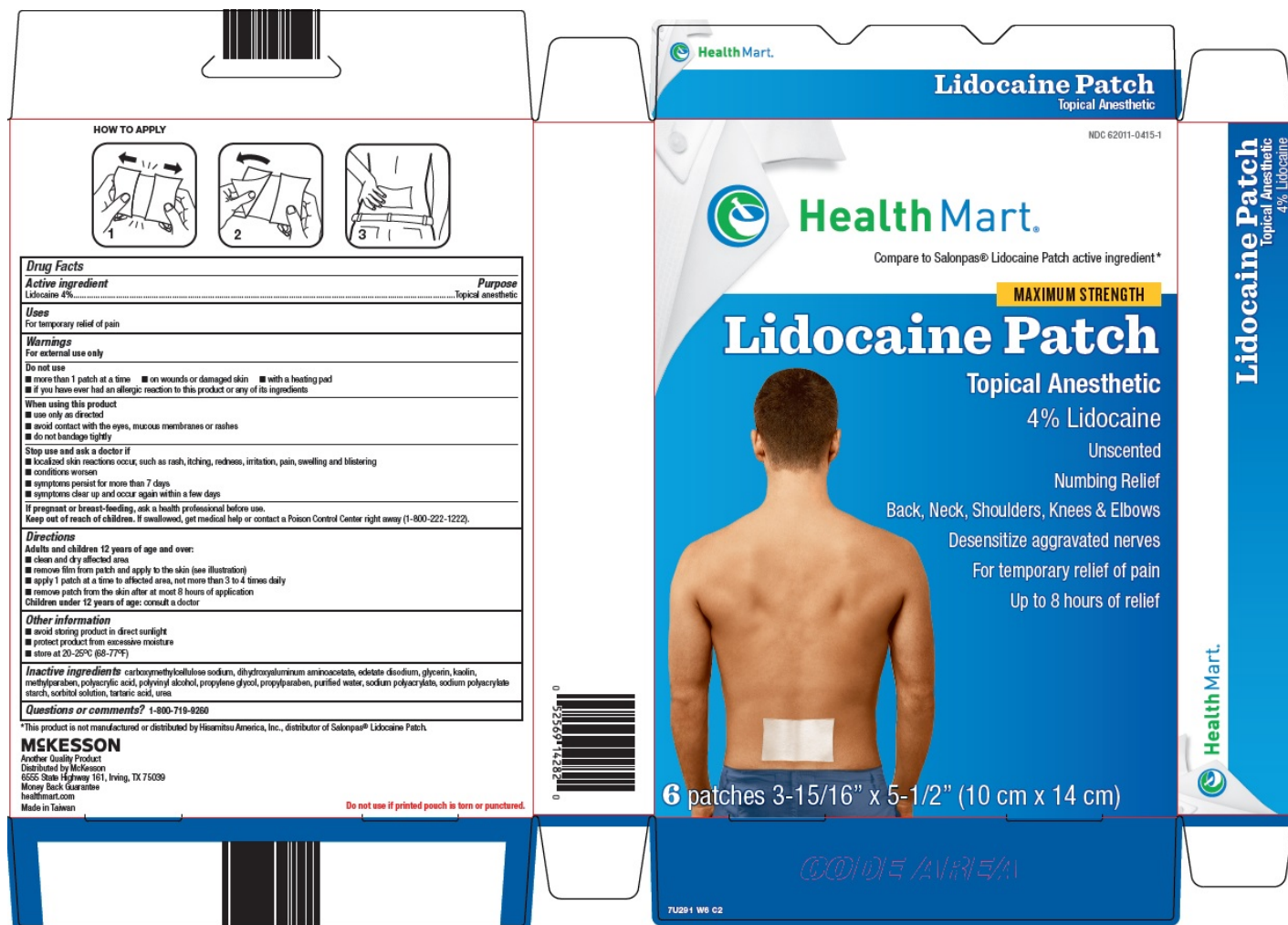
