Active ingredient (in each softgel)

Diphenhydramine HCl 25 mg

Purpose

Nighttime sleep-aid

Uses

- for relief of occasional sleeplessness
- reduces time to fall asleep if you have difficulty falling asleep

Warnings

Do not use • for children under 12 years of age

- with any other product containing diphenhydramine, even one used on skin
- with other drugs that cause drowsiness such as antihistamines and nighttime cold/flu products

Ask a doctor before use if you have • glaucoma • heart diseases

- a breathing problem such as emphysema, asthma, or chronic bronchitis
- difficulty in urination due to enlargement of the prostate gland

Ask a doctor or pharmacist before use if you are taking sedatives, tranquilizers, or any other sleep aid

When using this product • avoid alcoholic beverages and other drugs that cause drowsiness. Be careful when driving a motor vehicle or operating machinery.

Stop use and ask a doctor if sleeplessness persists continuously for more than 2 weeks. Insomnia may be a symptom of a serious underlying medical illness.

If pregnant or breast-feeding, ask a health professional before use.

Keep out of reach of children.

Overdose warning: In case of overdose, get medical help or contact a Poison Control Center right away. Prompt medical attention is critical for adults as well as children even if you do not notice any signs or symptoms.

Directions

- take only one dose (2 softgels) per day (24 hours)

adults and children 12 years and over	take 2 softgels at bedtime if needed or as directed by a doctor
children under 12 years	do not use

Other information

- store at room temperature between 20°-25°C (68°-77°F)
- protect from light, heat and moisture

edible white ink, FD&C blue no.1, FD&C red no.40, gelatin(bovine), glycerin, isopropyl alcohol, medium chain triglycerides, polyethylene glycol 400, povidone K-30, purified water, sorbitol sorbitan solution

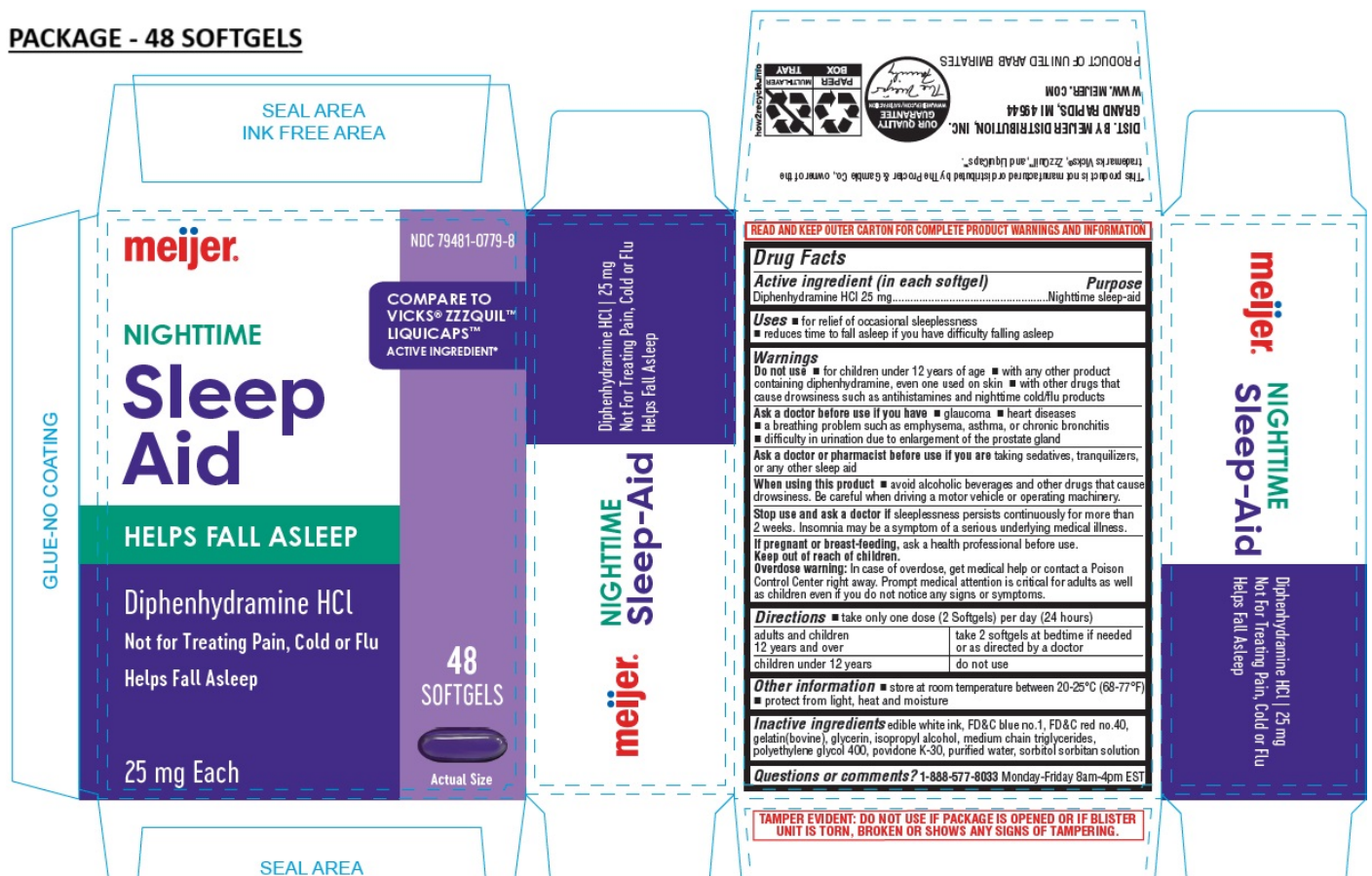
