Ask a doctor before use if you have

Ask a doctor or pharmacist before use if you are

- mouth, teeth, or jaw problems occur
- irregular heartbeat or palpitations occur
- you get symptoms of nicotine overdose such as nausea, vomiting, dizziness, diarrhea, weakness, and rapid heartbeat
- you have symptoms of an allergic reaction (such as difficulty breathing or rash)

- if you are under 18 years of age, ask a doctor before use

- if you smoke your first cigarette within 30 minutes of waking up, use 4 mg nicotine gum

- to improve your chances of quitting, use at least 9 pieces per day for the first 6 weeks
