In the event of liquefaction, refrigerate for 10 minutes.

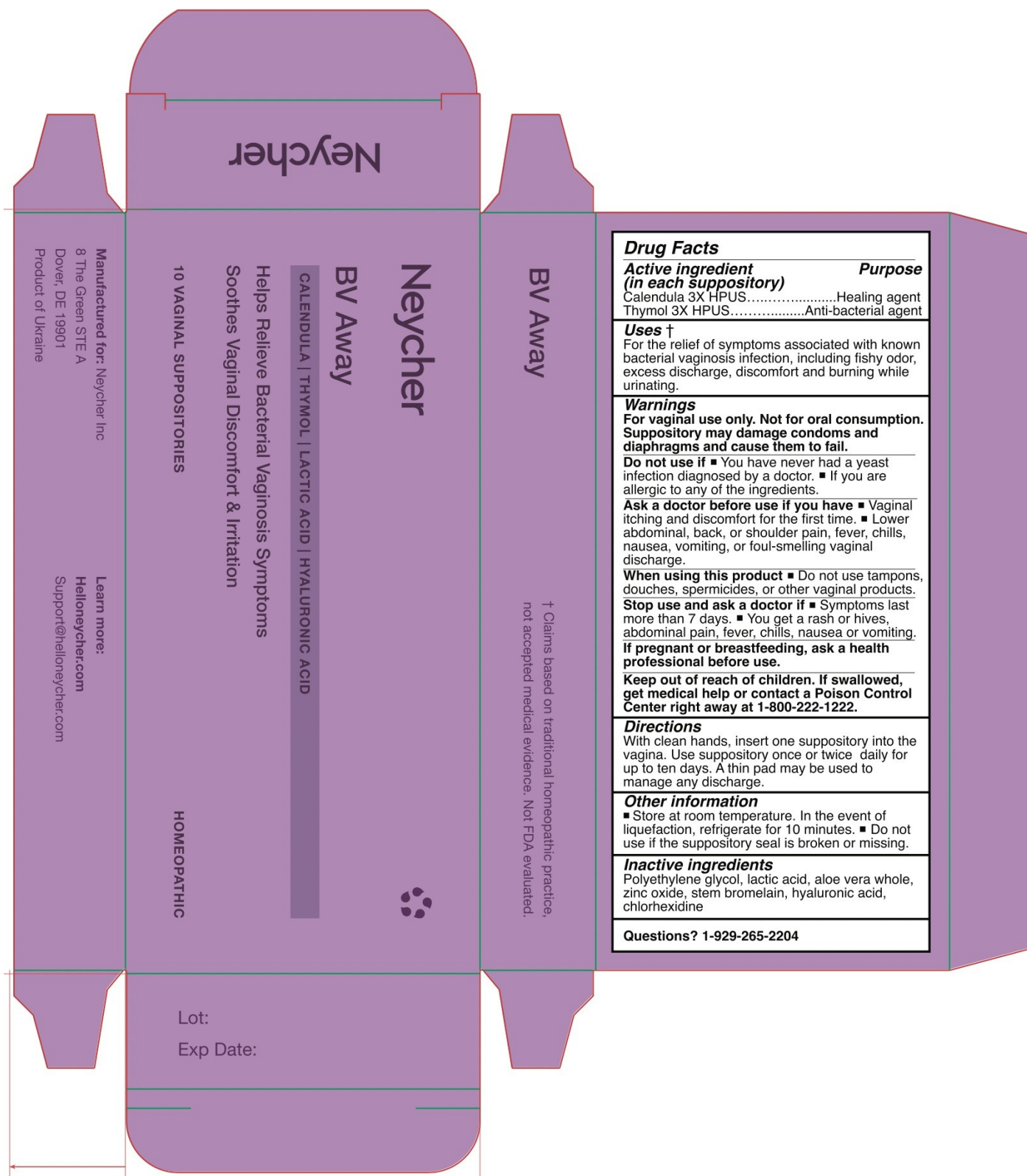
