Directions

- adults and children 12 years and older:
 - use the tip of the cap to break the seal and open the tube
 - wash the affected skin with soap and water and dry completely before applying
 - **for athlete's foot between the toes:** apply to affected skin between and around the toes twice a day for 1 week (morning and night), or once a day for 4 weeks, or as directed by a doctor. Wear well-fitting, ventilated shoes. Change shoes and socks at least once daily.

Apply between and around the toes



1 week twice a day or 4 weeks once a day

- **for jock itch and ringworm:** apply once a day to affected skin for 2 weeks or as directed by a

doctor.

- wash hands after each use
- children under 12 years: ask a doctor
