 - Reapply at least every 2 hours
 - Use a water resistant sunscreen if swimming or sweating

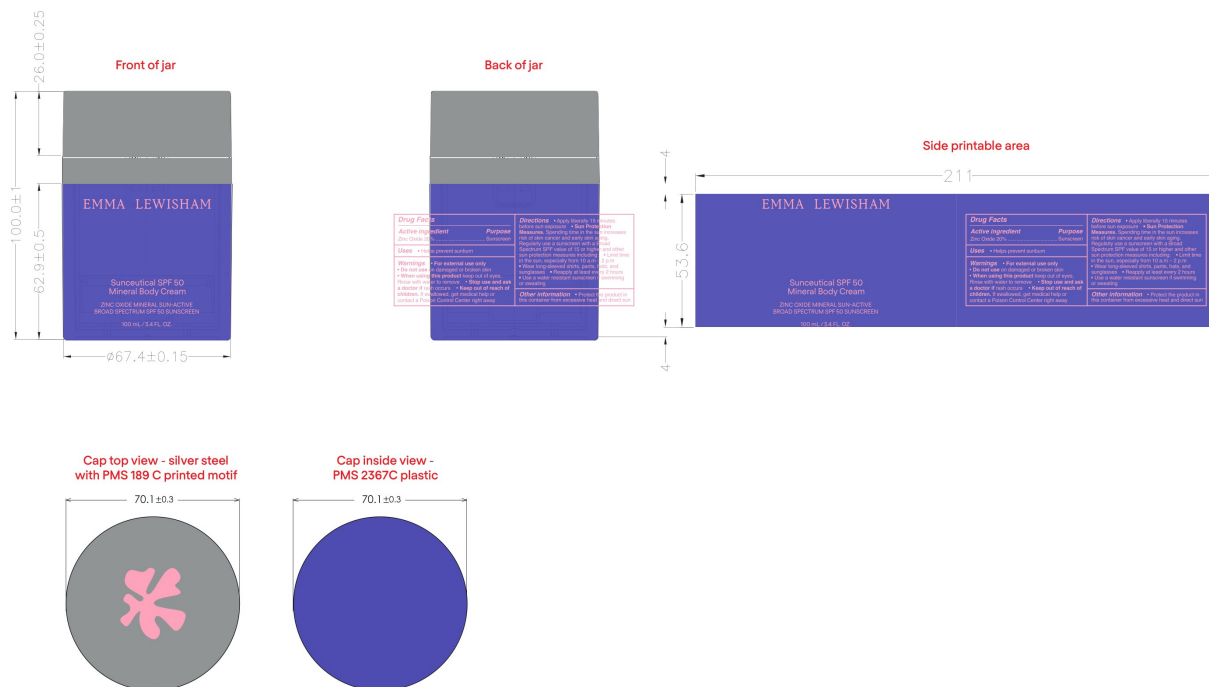






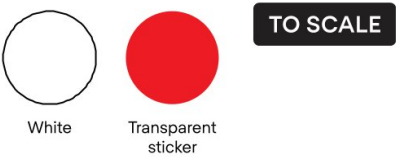
