DIRECTIONS FOR USE

Use Hand San in conjunction with standard hand washing procedures after every absence from workstation and as specified by management to reduce risk of cross contamination, such as hand-to-food and hand-to-equipment, contamination. After washing hands, spray entire surface of hands, including fingertips and cuticles. Rub hands vigorously until dry. No rinse or toweling is required.
