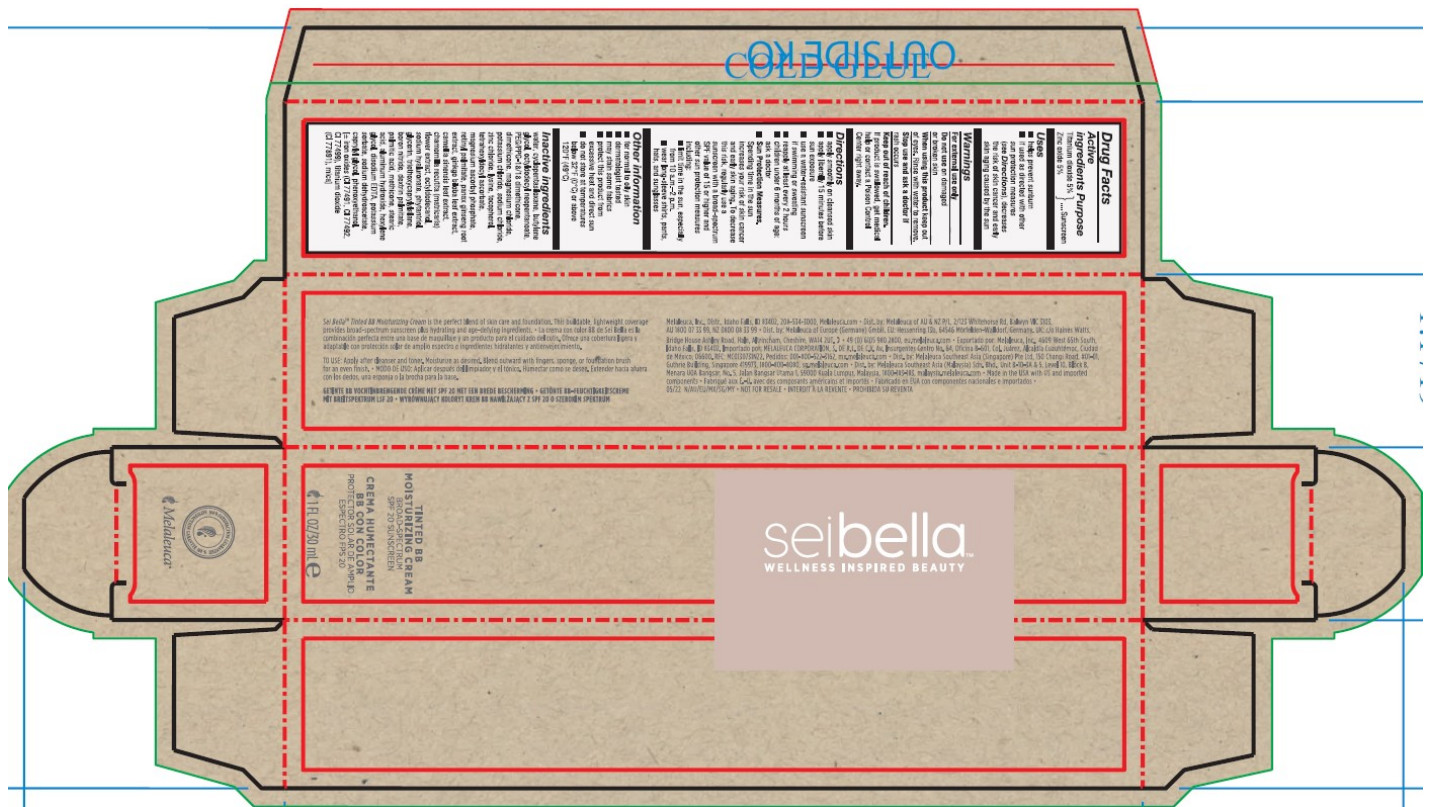

- for normal to oily skin
- dermatologist tested
- may stain some fabrics
- protect this product from excessive heat and direct sun
- do not store at temperatures below 32°F (0°C) or above 120°F (49°C)
