Purpose

Use

temporarily relieves:

- Cough due to a cold
- occasional minor irritation, pain, sore mouth, and sore throat

Warnings

Sore throat warning: If sore throat is severe, persists for more than 2 days, is accompanied or followed by fever, headache, rash, swelling, nausea, or vomiting, consult a doctor promptly.

Ask a doctor before use if you have: ■ a persistent or chronic cough such as occurs with smoking, asthma, or emphysema ■ a cough accompanied by excessive phlegm (mucus).

Stop use and ask a doctor if:

- cough persists for more than 1 week, tends to recur, or is accompanied by fever, rash, or persistent headache. A persistent cough may be a sign of a serious condition
- sore mouth symptoms do not improve in 7 days
- irritation, pain, or redness persists or worsens

When using this product do not exceed recommended dosage

Directions

adults and children 2 years and over: slowly dissolve 2 drops (one at a time in mouth).

Repeat every 2 hours as needed, or as directed by a doctor
 children under 2 years: ask a doctor.
