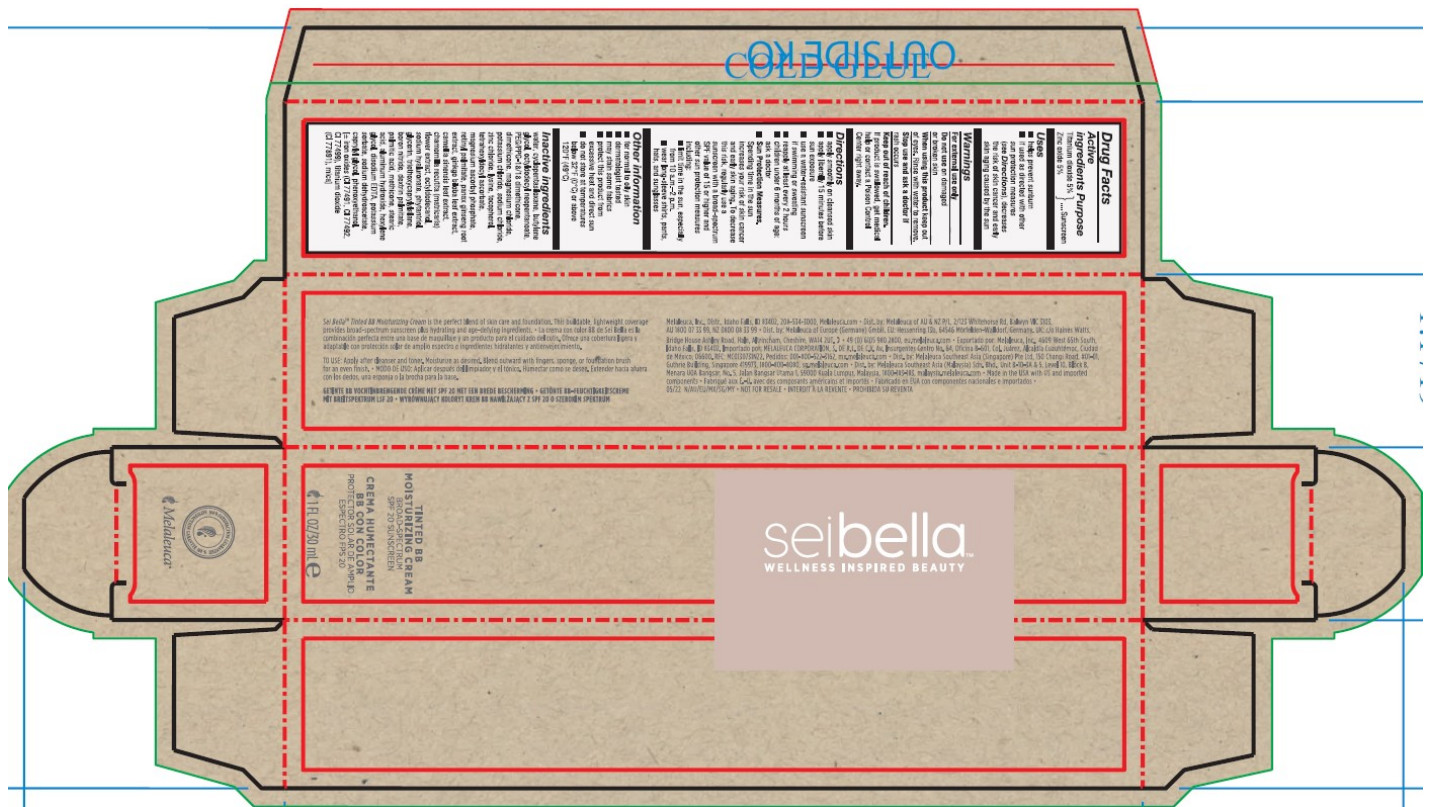
- limit time in the sun, especially from 10 a.m. – 2 p.m.
