ACTIVE INGREDIENT:
Zinc Oxide 20%

PURPOSE:
Sunscreen

USES:

Helps prevent sunburn. If used as directed with other sun protection measures (see directions), decreases the risk of skin cancer and early aging caused by the sun.

WARNINGS:

For external use only. Do not use on damaged or broken skin. Stop use and ask a doctor if rash occurs. When using this product, keep out of eyes. Rinse with water to remove. **Keep out of reach of children.** If swallowed, get medical help or contact a poison control center right away.

DIRECTIONS:

- Apply liberally 15 minutes before sun exposure
- Reapply:
 - After 40 minutes of swimming or sweating
 - Immediately after towel drying
 - Reapply at least every 2 hours
- Children under 6 months: Ask a doctor

Sun Protection Measures: Spending time in the sun increases your risk of skin cancer and early skin aging. To decrease this risk, regularly use a sunscreen with a broad spectrum SPF value of 15 or higher and other sun protection measures including:

- Limit time in the sun, especially from 10 am- 2 pm
- Wear long sleeve shirts and hats and sunglasses
