### **Purposes**

#### Uses

- For the temporary relief of minor aches and pains associated with hangover.
- Helps restore mental alertness or wakefulness when experiencing fatigue or drowsiness associated with a hangover.

### Warnings:

**Reye's syndrome:** Children and teenagers who have or are recovering from chicken pox or flu-like symptoms should not use this product. When using this product, if changes in behavior with nausea and vomiting occur, consult a doctor because these symptoms could be an early sign of Reye's syndrome, a rare but serious illness.

**Allergy alert:** Aspirin may cause severe allergic reaction which may include:

- hives
- facial swelling
- asthma (wheezing)
- shock.

**Stomach bleeding warning:** This product contains an NSAID, which may cause severe stomach bleeding. The chance is higher if you

- are age 60 or older
- have had stomach ulcers or bleeding problems
- take a blood thinning (anticoagulant) or steroid drug
- take other drugs containing prescription or non-prescription NSAIDs (aspirin, ibuprofen, naproxen, or others)
- have 3 or more alcoholic drinks every day while using this product
- take more or for a longer time than directed.

### Caffeine warning:

The recommended dose of this product contains about as much caffeine as a cup of coffee. Limit the use of caffeine-containing medications, foods, or beverages while taking this product because too much caffeine may cause nervousness, irritability, sleeplessness, and, occasionally, rapid heartbeat.

#### Do not use

- if you have ever had an allergic reaction to aspirin or any other pain reliever/fever reducer
- for more than 2 days for a hangover unless directed by a doctor. Not intended for use as a substitute for sleep. If fatigue or drowsiness persists or continues to recur, consult a doctor.
- in children under 12 years of age

#### Ask a doctor before use if

- stomach bleeding warning applies to you
- you have a history of stomach problems, such as heartburn
- you have high blood pressure, heart disease, liver cirrhosis, or kidney disease
- you are taking a diuretic
- you have asthma

### Ask a doctor or pharmacist before use if you are

taking a prescription drug for diabetes, gout, or\_arthritis

### Stop use and ask a doctor if

- an allergic reaction occurs. Seek medical help right away
- you experience any of the following signs of stomach bleeding:
  - feel faint
  - vomit blood
  - have bloody or black stools
  - have stomach pain that does not get better
  - ringing in the ears or a loss of hearing occurs

### If pregnant or breast-feeding,

ask a health professional before use. It is especially important not to use aspirin at 20 weeks or later in pregnancy unless definitely directed to do so by a doctor because it may cause problems in the unborn child or complications during delivery.

### Keep out of reach of children.

In case of overdose, get medical help or contact a Poison Control Center (1-800-222-1222) right away.

#### **Directions:**

- Adults and children 12 years and over: open 1 pack, place powder on tongue every 6 hours, while symptoms persist. Drink a full glass of water or other liquid.
- Do not take more than 4 packs in 24 hours unless directed by a doctor.
- Children under 12 years: ask a doctor.
