## **Directions**

1. Apply the product twice a day, in the morning and at night.
2. For initial use, soak the affected nail in warm water to soften it. Gently file the nail to make it thinner and remove dirt, being cautious not to harm the nail bed. For best results file nails every 2-3 days.
3. Hold the bottle at an angle to pour 2-3 drops. Use the brush applicator to apply the solution on the affected areas.
4. For best results, use this product consistently for 3-6 months, as fungal nail infections require prolonged treatment. Visible improvements may appear in as little as 7 days, but complete healing takes longer.

Preservation method

Store in a cool, shaded place away from direct sunlight. Store at room temperature between 15-30°C (59-86°F).
