  - After 80 minutes of swimming or sweating.
  - Immediately after towel drying
  - At least every 2 hours.
  - Children under 6 months: ask a doctor.
  - **Sun Protection Measures:** Spending time in the sun increases your risk of skin cancer and early skin aging. To decrease this risk, regularly use a sunscreen with a broad spectrum SPF of 15 or higher and other sun protection measures including:
  - Limit time in the sun, especially from 10 a.m. - 2 p.m.
  - Weat long-sleeve shirts, pants, hats and sunglasses.

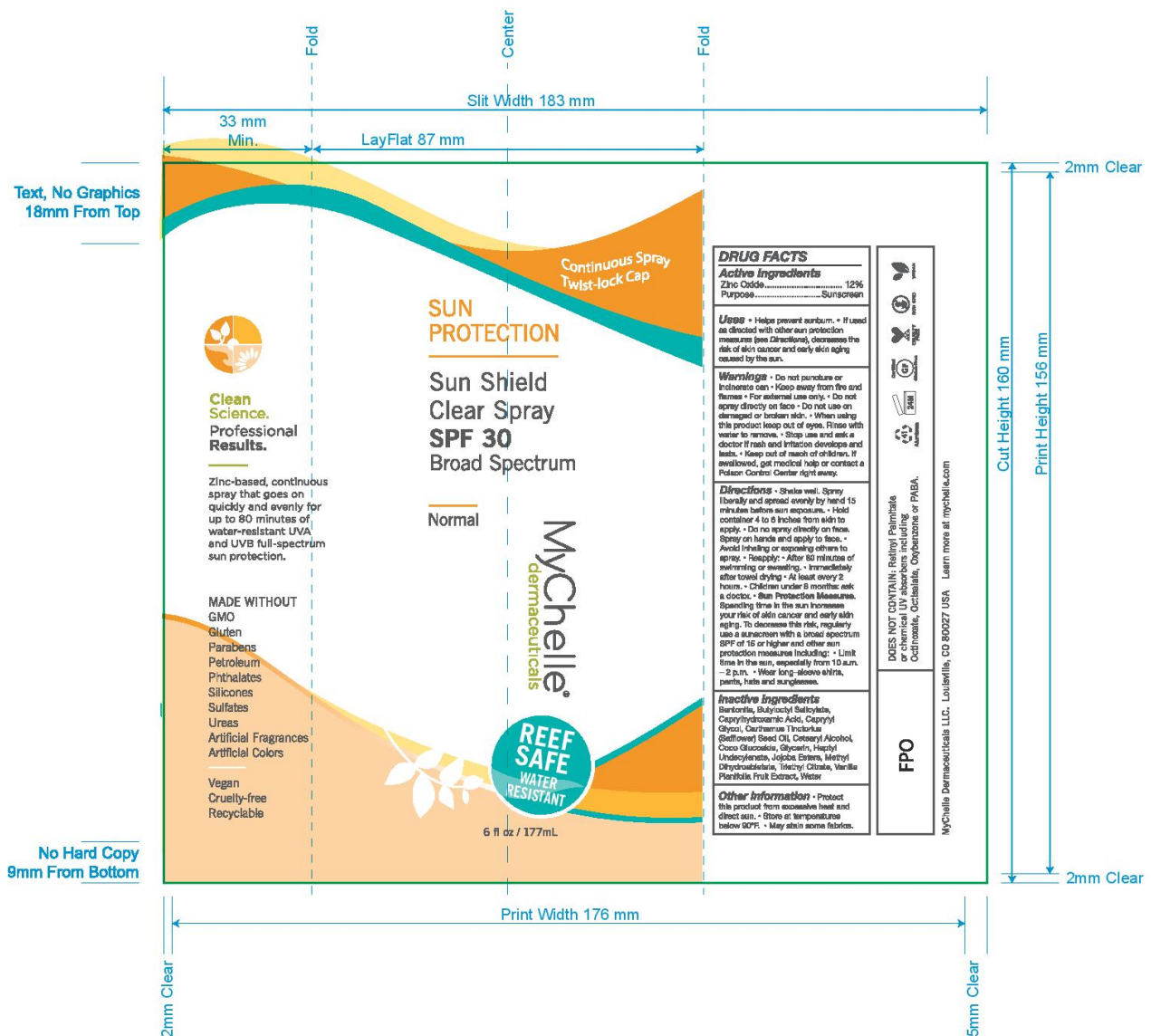
