#### ACTIVE INGREDIENT:

Zinc Oxide 20%

#### PURPOSE:

Sunscreen

#### USES:

Helps prevent sunburn. If used as directed with other sun protection measures (see directions), decreases the risk of skin cancer and early aging caused by the sun.

#### WARNINGS:
