 Use a cotton swab to apply a sufficient amount to cover each wart. Let it dry. Repeat this procedure once or twice daily as needed (until wart is removed) for up to 12 weeks.  
**Other information**  
 Store at room temperature.  
 Avoid excessive heat (37°C / 99°F).  
 Skin discoloration may occur during or after use.
