for the removal of common and plantar warts ● the common wart is easily recognized by the rough "cauliflower-like" appearance of the surface ● the plantar wart is recognized by its location only on the bottom of the foot, its tenderness and the interruption of the footprint pattern

wash the affected area may soak the wart in warm water for 5 minutes o dry area thoroughly o using the applicator (brush or cotton swab), apply one drop at a time to sufficiently cover each wart e allow it to fully absorb and let dry repeat this procedure once or twice daily as needed (until the wart is removed) for up to 12 weeks

keep out of reach of children, if swallowed, get medical help or contact a Poison Control Center right away
