




Bag-n-Box Installation Instructions for Manual Dispensers

1. Press your finger in to the perforated area on the bottom of this box and remove the entire key-hole shaped perforated area.
2. Locate the nozzle and pull it down through the bottom of the box.
3. Place the cartridge on the dispenser platform. Pull the nozzle down and with the thumb and forefinger, rotate the top of the tube so that the *arc of the half moon* portion of the pump is facing toward you.



4. Then place the top of the tube firmly in the neck of the upper locator and fit the ears of the half moon pump in the slots in the lower locator.



5. Before closing the cover, check to make sure the *arc of the half moon pump* is facing toward you and the *ears of the half moon pump* are firmly seated in the slots of the lower locator.






