Warnings

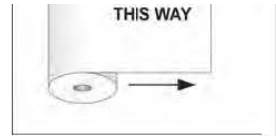

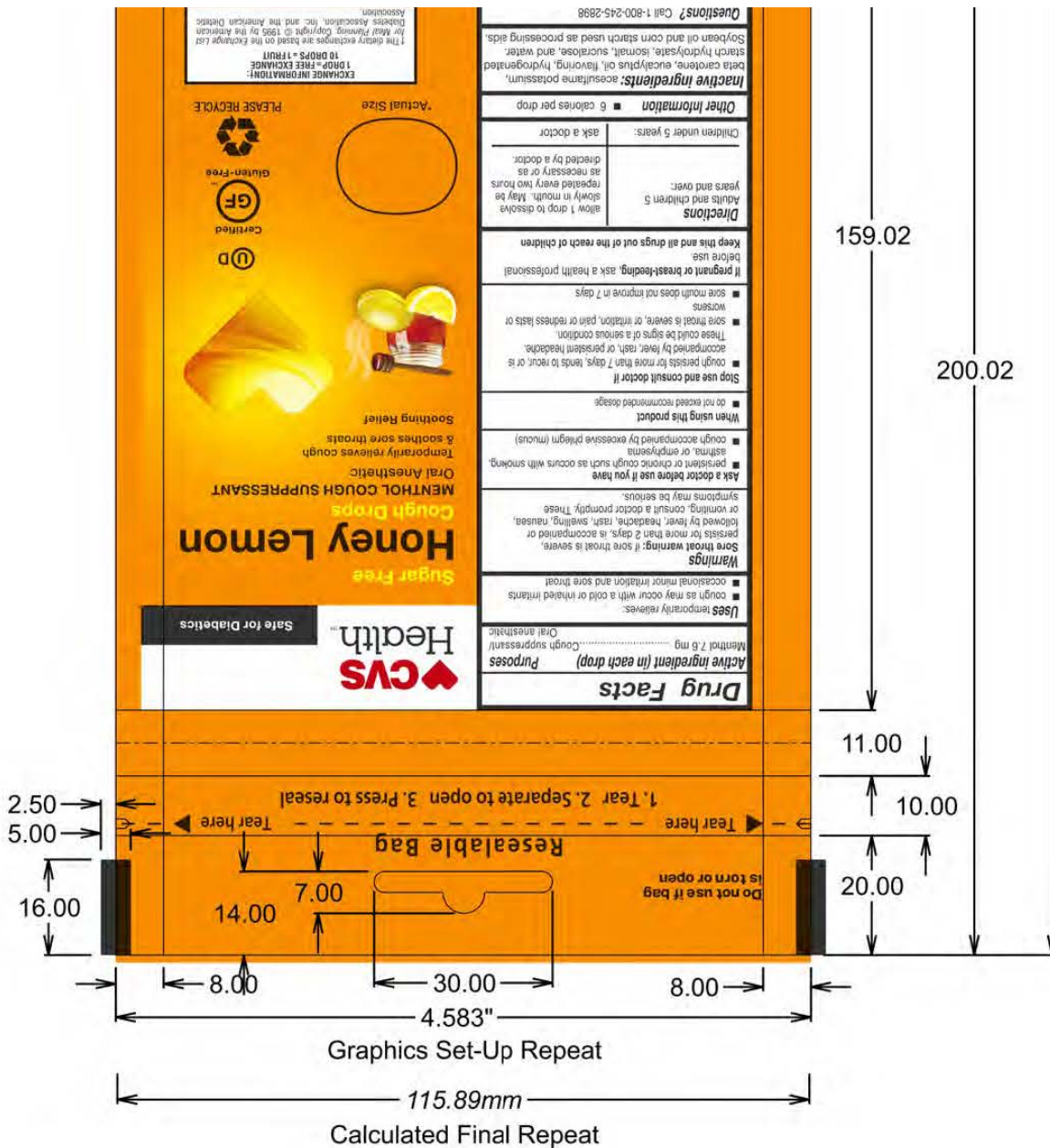
