- \*Allergies to adhesive tape or skin problems, as you are more likely to get rashes.
- \*Stomach ulcers or diabetes.
- \*History of seizures.

**ASK A DOCTOR OR PHARMACIST BEFORE USE IF YOU ARE :**

- \*Using a non-nicotine stop-smoking drug.
- \*Taking a prescription medicine for depression or asthma may mean that your dose needs adjusting.

**STOP USE AND ASK A DOCTOR IF:**

- \*Skin irritation (such as redness at the application site) persists for more than four days, or if you develop swelling, rash, or severe discomfort at the site of application.
- \*You experience irregular heartbeat or palpitations.
- \*You show signs of nicotine overdose, including nausea, vomiting, dizziness, weakness, or rapid heartbeat.
- \*You develop symptoms of a serious allergic reaction, such as difficulty breathing, swelling, or widespread rash.

**KEEP OUT OF REACH OF CHILDREN AND PETS:**

Used patches still contain enough nicotine to be harmful to children and pets. If a patch is swallowed, seek emergency medical assistance or contact a poison control center immediately.  
Retain the pouch for safe disposal. To discard, fold the patch with the adhesive sides together and place it back into the pouch before disposing.

- \*If you are under 18 years of age, consult a doctor before use. Before using this product, read the enclosed self-help guide for complete directions and other information.
- Begin using the patch on your quit day.
- \*If you smoke more than 10 cigarettes per day, follow the schedule below:

| Weeks 1-4                 | Weeks 5-6                 | Weeks 7-8                |
|---------------------------|---------------------------|--------------------------|
| Step 1                    | Step 2                    | Step 3                   |
| Use one 21 mg patch / day | Use one 14 mg patch / day | Use one 7 mg patch / day |

If you smoke 10 or fewer cigarettes per day: use Step 2 patch for 6 weeks, then Step 3 for 2 weeks.  
Apply one patch every 24 hours to clean, dry, hairless skin.  
Remove backing and apply immediately. Press firmly for 10 seconds.  
Wash hands after applying or removing.  
Fold used patch with sticky sides together and place in pouch for disposal.  
Change application site daily to avoid skin irritation.  
Use only one patch at a time.  
Do not wear longer than 24 hours, as it may irritate skin and lose effectiveness.
