*nonsteroidal anti-inflammatory drug

Purpose

Pain reliever/fever reducer

Uses

- temporarily relieves minor aches and pains due to:
 - headache
 - muscular aches
 - the common cold
 - toothache
 - menstrual cramps
 - backache
 - minor pain of arthritis
- temporarily reduces fever

Warnings
