Directions

- adults and children 12 years of age and older: clean and dry affected area, pop apart and partially peel back protective film and apply exposed patch to site of pain
- carefully remove the remaining film while pressing the patch firmly on the skin
- use on affected area not more than 3 to 4 times daily
- use one patch per application
- discard after use
- reseal pouch after opening to store unused patch
- children under 12 years of age: consult a physician
- wash hands after use with cool water

- store at room temperature, not to exceed 86°F (30°C)
- store in a cool dry place, away from direct sunlight
