Wart Remover

Use

For the removal of common warts. The common wart is easily recognized by the rough 'cauliflower-like' appearance of the surface.

Warnings

For external use only

Do not use

- On irritated, infected or reddened skin
- On genital warts and warts on the face
- On moles, birthmarks and warts with hair growing from them
- On mucous membranes

When using

Ask a doctor before use if you have diabetes or poor blood circulation.

Keep out of reach of children

If swallowed, get medical help or contact a Poison Control Center right away.

Directions

- Wash affected area may soak wart in warm water for 5 minutes
- Dry area thoroughly
- Remove bandage strips by peeling back off
- If necessary, cut medicated patch to fit wart
- Carefully apply medicated plaster
- Repeat procedure every 48 hours as needed(until wart is removed) for up to 12 weeks

Other information

Store between 59° and 86°F (15° and 30° C).

Inactive ingredients Hard paraffin, lanolin, phenol, borneol, crocus sativus L, gleditsia sinensis Lam

Dosage&administration section

One patch per day, each patch contains 12 mg of salicylic acid.
