## Directions

### adults and children 12 years or over:

- at first sign of a cold sore, apply liberally at least 4 times a day to affected area on lips
- as a protectant, apply liberally to lips as often as needed or at least twice daily
- for cracking and dryness continue to cover lips until absorbed
- apply liberally 15 minutes before sun exposure and at least every 2 hours when in sun
- use a water resistant sunscreen on lips if swimming or sweating
- **Sun protection measures:** Spending time in the sun increases your risk of skin cancer and early skin aging. To decrease this risk, regularly use a sunscreen with a Broad Spectrum SPF value of 15 or higher and other sun protection measures including:
  - limit time in sun, especially from 10am - 2pm
  - Wear long-sleeved shirts, pants, hats and sunglasses

**children under 12 years:** ask a doctor

- protect the product in this container from excessive heat and direct sun
