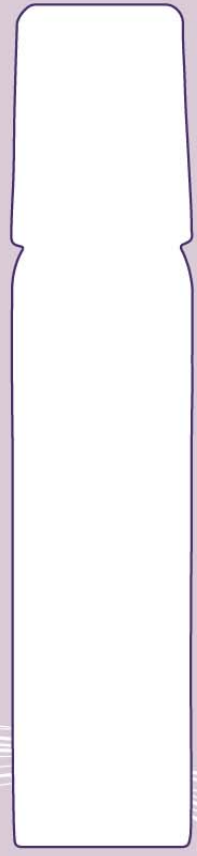

- 1: PREP HANDS WITH COLD WATER**  
 Rinse your fingers in cold water and dry them. **Note:** Foam will melt on contact with warm surfaces.
- 2: OPEN CHILD RESISTANT CAP**  
 Be sure to align arrow on the cap with arrow on white ring. Tilt cap back and pull off.
- 3: DISPENSE VERTICALLY ONTO A COLD SURFACE**  
 Hold the can straight upside down. If you hold the can at an angle, foam may not dispense properly. Press nozzle to dispense half a capful of foam onto a cold surface (e.g. dish, or cold hands).
- 4: APPLY TO SCALP, NOT HAIR**
