**When using this product**

***Directions***

**■ for itching of skin irritation, inflammation, and rashes:**

- adults and children 2 years of age and older: apply to affected area not more than 3 to 4 times daily

- children under 2 years of age: ask a doctor

**■ for external anal and genital itching, adults:**

- when practical, clean the affected area with mild soap and warm water and rinse thoroughly

- gently dry by patting or blotting with toilet tissue or a soft cloth before applying

- apply to affected area not more than 3 to 4 times daily

- children under 12 years of age: ask a doctor
