**Purpose**

Nasal decongestant

**Uses**

**Do Not Use**

If you do not know if your prescription drug contains an MAOI, ask a doctor or pharmacist before taking this product.

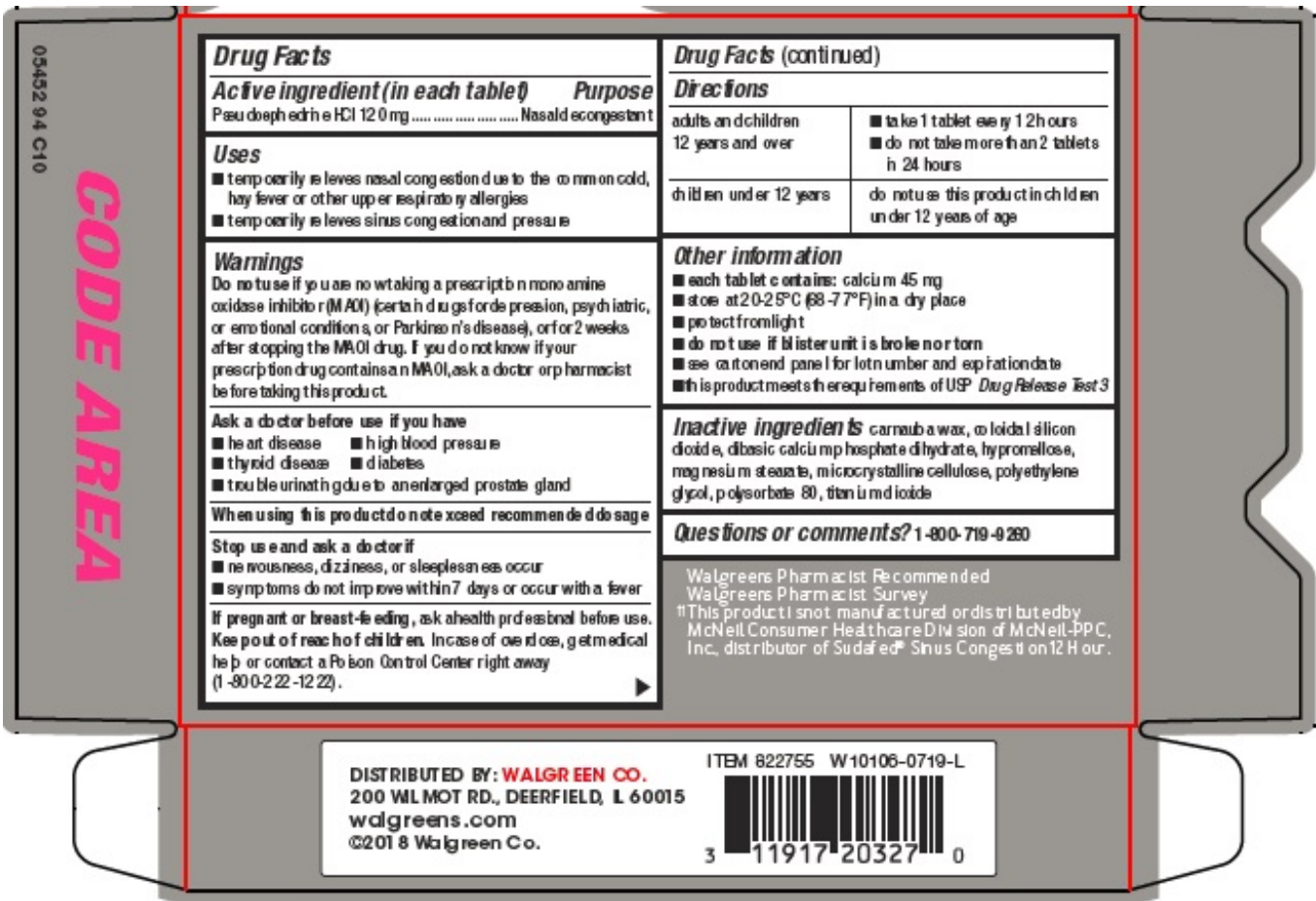
