Active ingredient

Salicylic acid 40% w/w

Purpose

Wart remover

Use

for the removal of common warts. The common wart is easily recognized by the rough 'cauliflower-like' appearance of the surface.

Warnings

For external use only.

Do not use

- on irritated, infected or reddened skin
- on genital warts or warts on the face
- on moles, birthmarks and warts with hair growing from them
- on mucous membranes
- if you are a diabetic or if you have poor blood circulation

Stop use and ask a doctor if

discomfort persists

Keep out of reach of children

If swallowed, get medical help or contact a Poison Control Center right away.

Directions

- wash affected area
- may soak wart in warm water for 5 minutes
- dry area thoroughly
- if necessary, cut medicated patch to fit wart
- carefully adhere medicated patch directly over wart
- cover patch with pad to conceal area
- repeat this procedure every 48 hours as needed (until wart is removed) for up to 12 weeks

Other information

- store between 59° and 86°F (15° and 30°C)
- avoid surrounding skin when applying medicated product

acrylic adhesive, acrylic polymer, polyethylene, polyvinyl alcohol
