DIRECTIONS

Ponds with plants: add 1-1/4 cups of POND SALT for each 100 U.S. gallons of pond water (or 100 g for 100 L of pond water).

Ponds without plants: add 2-1/2 cups of POND SALT for each 100 U.S. gallons of pond water (or 200 g for 100 L of pond water).

Disease treatment: Short-term salt baths are beneficial to kill external parasites and treat fungal infections. In a plastic container dissolve 2-1/2 cups of POND SALT in 10 U.S. gallons of pond water (or 200 g for 10 L of pond water). Do not use tap water. Carefully place infected fish in the salt bath for 5-10 minutes. Do not leave fish in the salt bath for more than 10 minutes. Return the fish to the pond. Treatment may be repeated after 24 hours.
