This fluid acts as a lubricant and shock absorber and filter controlling the movement of cells and large molecules within the joints. It is used to treat knee pain caused by osteoarthritis.

Calcium Fructoborate:

Calcium fructoborate is a compound of boron, fructose, and calcium and may improve blood lipids, reduce inflammation and oxidation, complement cancer therapy, and treat osteoporosis with few side effects. Combining calcium fructoborate with glucosamine and chondroitin may boost measures of joint health.
