Cetirizine HCl 5 mg

**Purpose**

Antihistamine

**Uses**

temporarily relieves these symptoms due to hay fever or other upper respiratory allergies:

- runny nose
- sneezing
- itchy, watery eyes
- itching of the nose or throat

**Warnings**

**Do not use**

if you have ever had an allergic reaction to this product or any of its ingredients or to an antihistamine containing hydroxyzine.

**Ask a doctor before use if you have**

liver or kidney disease. Your doctor should determine if you need a different dose.

**Ask a doctor or pharmacist before use if you are**

taking tranquilizers or sedatives.

**When using this product**

- drowsiness may occur
- avoid alcoholic drinks
- alcohol, sedatives, and tranquilizers may increase drowsiness
- be careful when driving a motor vehicle or operating machinery

**Stop use and ask a doctor if**

an allergic reaction to this product occurs. Seek medical help right away.

## If pregnant or breast-feeding:

- if breast-feeding: not recommended
- if pregnant: ask a health professional before use.

## Keep out of reach of children.

## Directions

- use only with enclosed dosing cup
- find right dose on chart below
- mL = milliliter

adults and children 6 years and over	5 mL or 10 mL once daily depending upon severity of symptoms; do not take more than 10 mL in 24 hours.
adults 65 years and over	5 mL once daily; do not take more than 5 mL in 24 hours.
children 2 to under 6 years of age	2.5 mL once daily. If needed, dose can be increased to a maximum of 5 mL once daily or 2.5 mL every 12 hours. Do not give more than 5 mL in 24 hours.
children under 2 years of age	ask a doctor
consumers with liver or kidney disease	ask a doctor

## Other information

- store between 20° to 25°C (68° to 77°F)
- **do not use if carton is opened, or if printed neckband is broken or missing**
- see bottom panel for lot number and expiration date

anhydrous citric acid, artificial grape flavor, propylene glycol, purified water, sodium benzoate, sorbitol solution, sucralose
