Stop use and contact your physician if

- your symptoms do not improve within 3 days or if symptoms last more than 7 days.
- you get a rash, hives, abdominal pain, fever, chills, nausea, vomiting, or foul-smelling vaginal discharge.

**If pregnant or breastfeeding,** ask a health professional before use.

**Keep out of reach of children.**

If swallowed, get medical help or contact a Poison Control Center right away.

☐ **Directions:** Adults: take one tablet orally three times a day as long as symptoms persist. Children: consult a physician prior to use.

- For occasional support take one tablet per day.

### **Other Information:**

*Each one tablet dose contains 35 mg calcium. Store at room temperature. Do not expose to excessive heat, humidity or direct sunlight.*

- Tamper evident: tablets sealed in blisters. Do not use if blister foil or seal is open or damaged.
