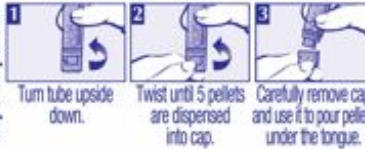

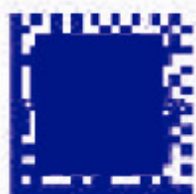

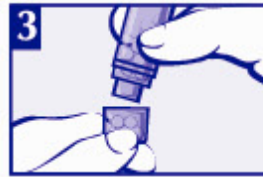
How to
