GENERAL RECOMMENDATIONS

To make a ready-to-use solution of Ultra-Guard Sanitizing Barrier Teat dip, add equal volumes of Ultra-Guard Activator and Ultra-Guard Base into a clean dip cup/container and mix until the color is uniform throughout. Do not dilute. Mix only the amount needed for one milking of the herd. Discard any unused teat dip. Do not mix with any other products.

RECOMMENDED PROCEDURES FOR TEAT SANITATION

POST-MILKING (POST-DIPPING)

Immediately after milking, dip all teats full length with READY-TO-USE ULTRA-GUARD SANITIZING BARRIER TEAT DIP. Ensure good coverage of all sides of the teats and teat orifices. Allow to dry. Do not wipe. Do not turn cows out in freezing weather until teat dip is completely dry.

NOTE: Before milking, use a compatible teat dip or udder wash to thoroughly clean the teats.

Do not return teat dip left in the teat dipper to storage container.

Ensure that dipped teats are dry before exposing the animals to weather conditions which may cause damage to the teats.

Protect this product from freezing. However, freezing will not affect ULTRA-GUARD ACTIVATOR provided that the contents are thawed completely and agitated thoroughly

before mixing base and activator together.
