**THERASTAT, CHERRY**

***Active ingredient (in each lozenge)***

Menthol 7 mg

***Purpose***

Cough suppressant/oral anesthetic

***Uses***

Temporarily relieves sore throat and cough occurring with a cold

***Warnings***

Sore throat warning: If sore throat is severe, persists for more than 2 days, is accompanied or followed by fever, headache, rash, nausea, or vomiting, consult a doctor right away

**Ask a doctor before use if you have**

- a cough accompanied by excessive phlegm (mucus)
- a persistent or chronic cough such as occurs with smoking, asthma, or emphysema

**Stop use and ask a doctor if:**

- sore mouth does not improve in 7 days
- irritation, pain or redness persists or worsens
- cough persists for more than 1 week, tends to recur, or is accompanied by fever, rash, or persistent headache

These could be signs of a serious condition

**If pregnant or breast-feeding**, ask a health professional before use.

**Keep out of reach of children.** In case of overdose, get medical help or contact a Poison Control Center right away. 1-800-222-1222

***Directions***

**Do not take more than directed**

Adults and children 12 years of age and over:

- allow one lozenge to dissolve slowly in mouth
- may be repeated every 2 hours as needed or as directed by a doctor


Children under 12 years of age: ask a doctor

***Other information***

- **Contains: SOY**

- store at 59° to 86°F (15°-30°C) in a dry place
- avoid excessive heat and humidity
