***Active ingredient (in each tablet)***

Acetaminophen USP, 325 mg

***Purpose***

Pain reliever/fever reducer

***Uses***

- temporarily relieves minor aches and pains due to:
- headache
- muscular aches
- backache
- minor pain of arthritis
- the common cold
- toothache
- premenstrual or menstrual cramps
  
- temporarily reduces fever

***Warnings***

**Liver warning:** This product contains acetaminophen. Severe liver damage may occur if

- adult takes more than 4,000 mg in 24 hours, which is the maximum daily amount
- child takes more than 5 tablets in 24 hours, which is the maximum daily amount
- taken with other drugs containing acetaminophen
- adult has 3 or more alcoholic drinks while using this product

**Allergy alert:** acetaminophen may cause severe skin reactions. Symptoms may include:

- skin reddening
- blisters
- rash

If a skin reaction occurs, stop use and seek medical help right away.

**Do not use** with any other drug containing acetaminophen (prescription or nonprescription). If you are not sure whether a drug contains acetaminophen, ask a doctor or pharmacist.

**Ask a doctor before use if the user has** liver disease

**Ask a doctor or pharmacist before use if the user is** taking the blood thinning drug warfarin

**Stop use and ask a doctor if**

- pain gets worse or lasts more than 10 days in adults

- pain gets worse or lasts more than 5 days in children
- fever gets worse or lasts more than 3 days
- new symptoms occur
- redness or swelling is present

These could be signs of a serious condition.

**If pregnant or breast-feeding**, ask a health professional before use.

**Keep out of reach of children.**

**Overdose warning:** Taking more than the recommended dose (overdose) may cause liver damage. In case of overdose, get medical help or contact a Poison Control Center right away. Quick medical attention is critical for adults as well as for children even if you do not notice any signs or symptoms.

**Directions**

- **do not take more than directed (see overdose warning)**

adults and children 12 years and over	take 2 tablets every 4-6 hours while symptoms last, not more than 12 tablets in 24 hours
children 6 to 11 years	take 1 tablet every 4-6 hours while symptoms last, not more than 5 tablets in 24 hours
children under 6 years	do not use
