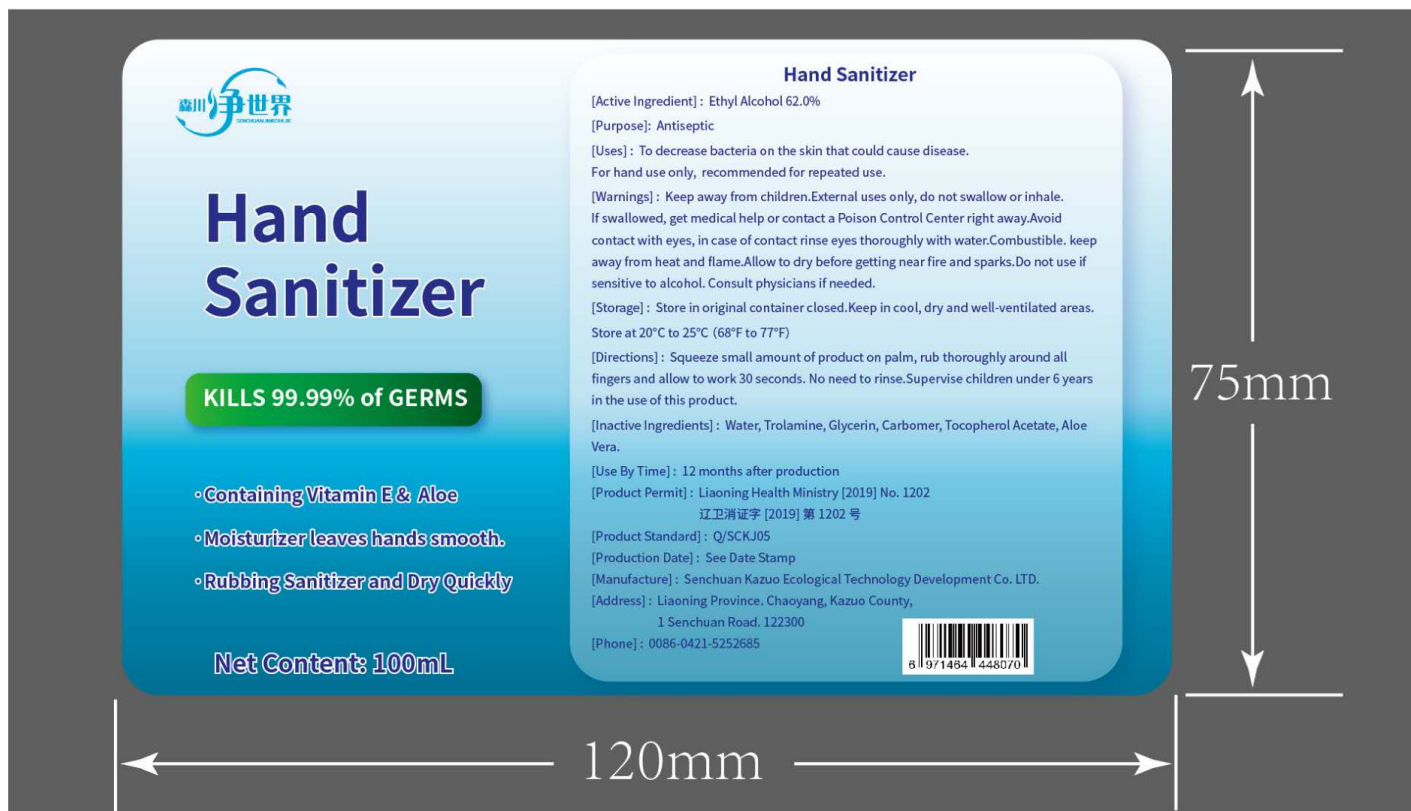
Storage
