- **TAMPER EVIDENT: DO NOT USE IF THE PULL TAB SEAL ON THE TUBE HAS BEEN REMOVED.**
- To open: unscrew cap, pull tab to remove foil seal, and screw cap back onto tube
- store between 20° to 25°C (68° to 77°F)
- See carton or tube crimp for lot number and expiration date

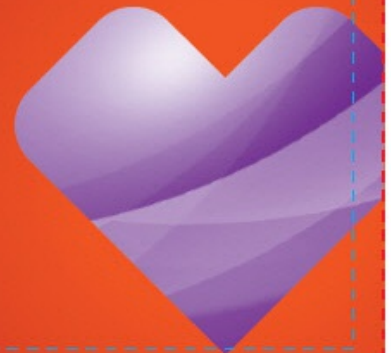

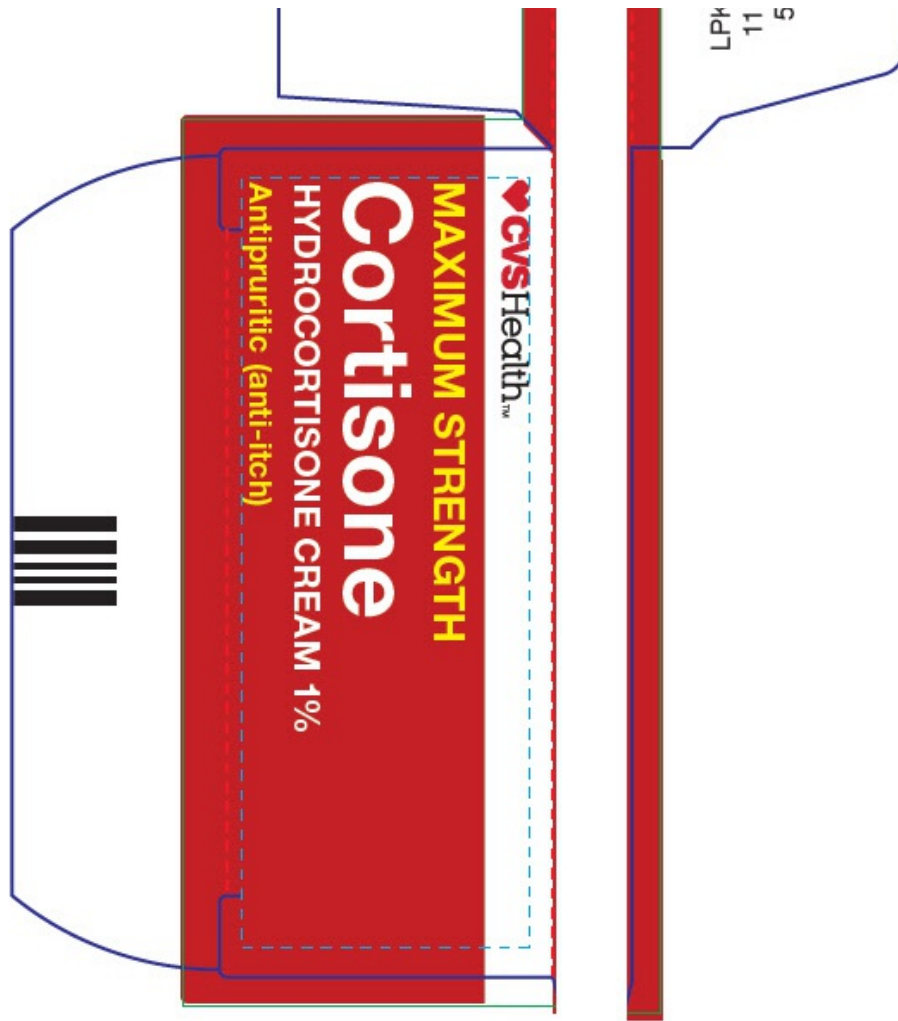
