**Active ingredient (in each tablet)**

Famotidine 20 mg

**Purpose**

Acid reducer

**Uses**

- relieves heartburn associated with acid indigestion and sour stomach
- prevents heartburn associated with acid indigestion and sour stomach brought on by eating or drinking certain food and beverages

**Warnings**

**Allergy alert:** Do not use if you are allergic to famotidine or other acid reducers

**Do not use**

- if you have trouble or pain swallowing food, vomiting with blood, or bloody or black stools. These may be signs of a serious condition. See your doctor.
- with other acid reducers

**Ask a doctor before use if you have**

- had heartburn over 3 months. This may be a sign of a more serious condition.
- heartburn with **lightheadedness, sweating, or dizziness**
- chest pain or shoulder pain with shortness of breath; sweating; pain spreading to arms, neck or shoulders; or lightheadedness
- frequent **chest pain**
- frequent wheezing, particularly with heartburn
- unexplained weight loss
- nausea or vomiting
- stomach pain
- kidney disease

**Ask a doctor or pharmacist before use if you are**

taking a prescription drug. Acid reducers may interact with certain prescription drugs.

**Stop use and ask a doctor if**

- your heartburn continues or worsens
- you need to take this product for more than 14 days

**If pregnant or breast-feeding,**

ask a health professional before use.

**Keep out of reach of children.**

In case of overdose, get medical help or contact a Poison Control Center right away. (1-800-222-1222)

**Directions**

- adults and children 12 years and over:
  - to **relieve** symptoms, swallow 1 tablet with a glass of water. Do not chew.
  - to **prevent** symptoms, swallow 1 tablet with a glass of water at any time from **10 to 60 minutes before** eating food or drinking beverages that cause heartburn
  - do not use more than 2 tablets in 24 hours
- children under 12 years: ask a doctor

**Other information**

- read the directions and warnings before use
- keep the carton. It contains important information.
- store at 20°-25°C (68°-77°F)
- protect from moisture

**Inactive ingredients**

colloidal silicon dioxide, croscarmellose sodium, FD&C blue #1 aluminum lake, hypromellose, lactose (monohydrate), magnesium stearate, maltodextrin, microcrystalline cellulose, modified food starch, natural and artificial flavor, sucralose, titanium dioxide, triacetin


