## Liver warning

- with other drugs containing acetaminophen
- 3 or more alcoholic drinks every day while using this product

## Allergy alert

acetaminophen may cause severe skin reactions. Symptoms may include:

- skin reddening
- blisters

rash

If a skin reaction occurs, stop use and seek medical help right away.

## Sore throat warning

If sore throat is severe, persists for more than 2 days, is accompanied or followed by fever, headache, rash, nausea, or vomiting, consult a doctor promptly.

#### Do not use

- with any other drug containing acetaminophen (prescription or nonprescription). If you are not sure whether a drug contains acetaminophen, ask a doctor or pharmacist.
- if you are now taking a prescription monoamine oxidase inhibitor (MAOI) (certain drugs for depression, psychiatric, or emotional conditions, or Parkinson's disease), or for 2 weeks after stopping the MAOI drug. - if you have ever had an allergic reaction to this product or any of its ingredients

## Ask a doctor before use if you have


