- adults and children 2 years and over: dissolve lozenge slowly in the mouth. Repeat every 2 hours as needed or as directed by a doctor
- children under 2 years of age: ask a doctor

- store at room temperature.
- keep away from excessive heat or sunlight
- do not use if primary bag seal has been torn or broken.
- contains: SOY
