Methenamine 162 mg

Sodium Salicylate 162.5 mg (NSAID Nonsteroidal Anti-Inflammatory Drug)

Purpose

Antibacterial

Analgesic (pain reliever)

Uses Temporarily relieves: pain & burning • frequency and urgency of urination

Warnings

Reye's syndrome: Children and teenagers who have or are recovering from chicken pox or flu-like symptoms should not use this product. If changes in behaviour with nausea and vomiting occur, consult a doctor because these symptoms could be an early sign of Reye's syndrome, a rare but serious illness.

Stomach bleeding warning: This product contains an NSAID, which may cause stomach bleeding. The chance is higher if you:

- take other drugs containing prescription or nonprescription NSAIDs (aspirin, ibuprofen, naproxen or others)
- have 3 or more alcoholic drinks every day while using this product
- have stomach ulcers or bleeding problems • take a blood thinning (anticoagulant) or steroid drug
- are age 60 or older • take more or for a longer time than directed

Do not use:

- if you are on a sodium restricted diet
- if you are allergic to salicylates (including aspirin) unless directed by a doctor

- if you have stomach problems (such as heartburn, upset stomach, or stomach pain) that persist or recur, or if you have ulcers or bleeding problems unless directed by a doctor

Ask a doctor before use if you have

- frequent, burning urination for the first time • the stomach bleeding warning applying to you
- history of stomach problems, such as heartburn
- high blood pressure • heart disease • liver cirrhosis • bleeding problems
- diuretic use • ulcers • kidney disease • reached age 60 or older

Ask a doctor or pharmacist before use if you are

- taking any other drug containing an NSAID (prescription or nonprescription)
- taking a blood thinning (anticoagulant), steroid, diabetes, gout or arthritis drug

When using this product • do not take more than the recommended dosage

Stop and ask a doctor if

- product has been used for 3 days
- you experience any of the following signs of stomach bleeding:
 - feel faint, vomit blood • have bloody or black stools • have stomach pain that does not get better
- ringing in the ears or a loss of hearing occurs

If pregnant or breast feeding, ask a health professional before use.

Directions: Adults and children 12 years and over: take 2 tablets with a full glass of water 3 times a day. Drink plenty of fluids. Children under 12 years: ask a doctor

The chance is higher if you ■ are 60 or older ■ have stomach ulcers or bleeding problems ■ take a blood thinning (anticoagulant) or steroid drug ■ take other drugs containing an NSAID (aspirin, ibuprofen, naproxen, or others) ■ have 3 or more alcoholic drinks every day while using this product ■ take more or for a longer time than directed

Do not use ■ if you are allergic to salicylates (including aspirin)

Stop use and ask a doctor if ■ product has been used for 3 days ■ ringing in the ears ■ you experience any of the following signs of stomach bleeding: ■ feel faint ■ vomit blood ■ have bloody or black stool ■ have stomach pain or upset that gets worse or lasts

If pregnant or breast feeding ask a health professional before use. It is especially important not to use this product (which contains sodium salicylate) during the last 3 months of pregnancy unless definitely directed to do so by a doctor because it may cause problems in the unborn child or complications during delivery.

Directions Adults and children 12 years and over: ■ take 2 tablets with a full glass of water 3 times a day. Drink plenty of fluids. Children under 12 years: ■ ask a doctor. Do not use for more than a 3 day period unless directed by a doctor.

Other information ■ each tablet contains: sodium 24.4 mg ■ store at 59-86°F (15-30°C) in a cool dry place ■ protect from sunlight
